NFSW is a multi-ministerial collaboration of activities by experts in food safety and is coordinated by the National Agricultural Health and Food Safety (NAH&FSC) Committee. The NAHFSCC was established in an advisory function relating to the coordination of food safety matters in Jamaica and has evolved as the coordinating team with oversight responsibility for food safety – "from the farm to consumption". The food safety regulatory programme is currently administered by six main entities/agencies distributed across the Ministries of Agriculture and Fisheries, Health and Industry, Investment and Commerce which are all represented on NAHFSCC. The National Food Safety Week is sponsored by the Inter-American Development Bank and the Agricultural Competitiveness Programme (ACP) through the Ministry of Agriculture and Fisheries.
